

NOTICE OF MEETING

HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 500 (Master)

The Board of Directors of Harris County Municipal Utility District No. 500 will hold a regular Master District meeting on **Wednesday, February 3, 2021, at 12:00 p.m.**, by teleconference* at Telephone Number: **888-363-4734, Access Code: 8706826**, to discuss and, if appropriate, act upon the following items:

1. Public comments (3-minute limit).
2. Approve minutes.
3. Receive electricity proposals, and authorize appropriate action.
4. Review Final Arbitrage Rebate Reports for the Series 2010 and Series 2012 Bonds and the Interim Report for the Series 2015 Bonds.
5. Financial and bookkeeping matters, including:
 - a. payment of the bills, review of investments, collection of monthly charges for operation and maintenance, and fund transfers; and
 - b. budget for fiscal year end March 31, 2022, including report from budget workshop.
6. Operation of District facilities, including:
 - a. billings, repairs, maintenance; and
 - b. update on water plant no. 1 piping rehabilitation project and replacement of pump level controller at lift station no. 2.
7. Discuss lake management and maintenance, including:
 - a. wildlife management, including report and proposals from A All Animal Control;
 - b. erosion, dredging, and water quality, including report from Erosion Control Committee;
 - c. Amendment to Maintenance Agreement with Towne Lake Community Association, Inc.; and
 - d. adopt Resolution Establishing Rules and Regulations Governing the Use of Harris County Municipal Utility District No. 500 lakes.
8. Engineering matters, including:
 - a. grade separation at Union Pacific Railroad and intersection improvements at Highway 290, including:
 - i. preliminary engineering and Advance Funding Agreement with TxDOT;
 - ii. update on Houston-Galveston Area Council Transportation Improvement Program participation;
 - iii. Interlocal Agreements with funding partners; and
 - iv. project schedule.
 - b. report on stormwater facilities maintenance and repairs, and approve Submerged Storm Sewer Agreements and Maintenance Agreements;

- c. authorize design, approve plans and specifications, authorize advertisement for bids, and review bids and award construction contracts, including for the following construction projects:
 - i. emergency water interconnect with Harris County Municipal Utility District No. 196;
 - ii. water well no. 1;
 - iii. wastewater treatment plant no. 2; and
 - iv. Mound Road east utility extension.
 - d. approve pay estimates, change orders, substantial completion, final acceptance, termination, and/or settlement agreements, including for the following construction projects:
 - i. wastewater treatment plant aeration and digester basin rehabilitation;
 - ii. clearing and grubbing for Detention 1L;
 - iii. water plant no. 2;
 - iv. Towne Lake Section 60 temporary access road;
 - v. Detention 1L (Phase Two); and
 - vi. Towne Lake Parkway, Segment 1 water, sewer, drainage and paving facilities.
 - e. approve requests for capacity reservations and utility commitment letters.
9. Accept or grant conveyance of deeds, utility deeds, and easements, approve consents to encroachment, rights of entry, abandonments of easements and environmental proposals.
 10. Update on park bond application no. 1, surplus funds applications for emergency water interconnect facilities, water well no. 1, and additional developer reimbursements.
 11. West Harris County Regional Water Authority matters, including surface water delivery.
 12. Landscape architect's report, including:
 - a. authorize design, approve plans and specifications, authorize advertisement for bids, and review bids and award construction contracts for landscaping/park facilities, including for the following projects:
 - i. Greenhouse Road, Segment Six; and
 - ii. trails, trees, and sidewalks.
 - b. approve pay estimates and change orders, substantial completion, final acceptance, termination, and/or settlement agreements, for landscaping/park facilities.
 13. Report regarding development in the District.
 14. Reports from District consultants regarding District correspondence and provision of records.
 15. Review and revise action list.
