

**NOTICE OF MEETING**

The Board of Directors of Harris County Municipal Utility District No. 500 will hold a regular meeting on **Wednesday, September 7, 2022, at 12:00 p.m.**, at **The Lakehouse, 10000 Towne Lake Parkway, Cypress, Texas**, to discuss and, if appropriate, act upon the following items:

2. CONSENT AGENDA: The following items are considered routine by the Board and will be enacted by one motion. No separate discussion will occur on these items unless a Board member so requests, in which event, the item will be removed and placed on the Non-Consent Agenda.
  - a. Approve minutes.
  - b. Financial and bookkeeping matters, including payment of the bills and review of investments.
  - c. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.
  - d. Reports from District consultants regarding District correspondence and provision of records.

  - f. Operation of District facilities, including billings, repairs and maintenance.
  - g. Engineering matters.

4. Additional financial and bookkeeping matters.
5. Discuss 2022 tax rate, set public hearing date, and authorize notice of public hearing regarding adoption of tax rate.
6. Security matters, including report from Harris County Sheriff's Office and approve Interlocal Agreement for Law Enforcement Services with Harris County.
7. Additional operational matters, including review and discuss Drought Contingency Plan and take action related to same, if necessary; adopt Order Adopting Amended and Restated Drought Contingency Plan, if necessary.
8. Hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
9. West Harris County Regional Water Authority matters, including surface water delivery.
10. Additional engineering matters, including:
  - a. approve Submerged Storm Sewer Agreements;

- b. requests for capacity reservation to Harris County Municipal Utility District No. 500 (Master) and requests for utility commitments; and
  - c. accept or grant conveyance of deeds and easements and approve consents to encroachment, rights of entry, and abandonment of easements.

  12. Review and revise action list.
  13. Convene in Executive Session pursuant to Section 551.071, Texas Government Code, to seek the advice of its attorney regarding pending or contemplated litigation or to seek and receive legal advice by the District's attorney.
  14. Reconvene in Open Session and authorize appropriate action regarding pending or contemplated litigation or the legal advice by the District's attorney
