## HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 500 (Master)

The Board of Directors of Harris County Municipal Utility District No. 500 will hold a regular Master District meeting on **Wednesday**, **September 7**, **2022**, **at 12:00 p.m.**, at <u>The Lakehouse</u>, **10000 Towne Lake Parkway**, **Cypress**, **Texas**, to discuss and, if appropriate, act upon the following items:

- 1. Public comments (3-minute limit).
- 2. Approve minutes.
- 3. Authorize auditor to prepare supplemental developer reimbursement report.
- 4. Financial and bookkeeping matters, including:
  - a. payment of the bills, review of investments, collection of monthly charges for operation and maintenance, and fund transfers; and
  - b. adopt Resolution(s) Expressing Intent to Reimburse.
- 5. Operation of District facilities, including:
  - a. billings, repairs, maintenance, and facility security, including telephone service options;
  - b. update on water plant no. 2 fence rehabilitation project and lift station no. 3 pump nos. 1 and 2 repairs;
  - c. update on landscape improvements at wastewater treatment plant site;
  - d. proposal for landscaping maintenance at wastewater treatment plant site and approve related agreement, if appropriate; and
  - e. discuss preparation of five-year facility maintenance plan.
- 6. Discuss lake management and maintenance, including:
  - a. wildlife management, including report and proposals from A All Animal Control;
  - b. erosion, dredging, and water quality, including report from Erosion Control Committee and update on development of lake maintenance plan;
  - c. amendments to lake rules, including request from Towne Lake Community Association and amendment to District lake rules; and
  - d. request from Federal Bureau of Investigation for Agreement for Use of Facilities for boat safety and navigation training.
- 7. Engineering matters, including:
  - a. grade separation at Union Pacific Railroad and intersection improvements at Highway 290, including:
    - i. authorize design of grade separation at Union Pacific Railroad and intersection improvements at Highway 290 project and, if appropriate, approve Agreement for Professional Engineering Services and Related Task Orders;
    - ii. Advance Funding Agreement with TxDOT;

- iii. update on Houston-Galveston Area Council Transportation Improvement Program participation;
- iv. Interlocal Agreements with funding partners;
- v. project schedule; and
- vi. updated analysis of financial impact of project.
- b. report on stormwater facilities maintenance and repairs, and approve Submerged Storm Sewer Agreements and Maintenance Agreements;
- c. authorize design, approve plans and specifications, authorize advertisement for bids, and review bids and award construction contracts, including for the following construction projects:
  - i. Mound Road east utility extension;
  - ii. wastewater treatment plant no. 1 generator;
  - iii. wastewater treatment plant no. 1 expansion, Phase 4; and
  - iv. Barker Cypress left turn lane.
- d. approve pay estimates, change orders, substantial completion, final acceptance, termination, and/or settlement agreements, including for the following construction projects:
  - i. wastewater treatment plant no. 2;
  - ii. emergency water interconnect with Harris County Municipal Utility District No. 196;
  - iii. Towne Lake Section 60 temporary access road; and
  - iv. water plant no. 1 water well no. 1 and hydropneumatic tank addition, including discuss resident communication plan.
- e. approve requests for capacity reservations and utility commitment letters;
- f. update on TPDES permit renewal application for Horsepen Creek Wastewater Treatment Plant; and
- g. discuss potential reclaimed water facilities at Horsepen Creek Wastewater Treatment Plant.
- 8. Accept or grant conveyance of deeds, utility deeds, and easements, approve consents to encroachment, rights of entry, abandonments of easements and environmental proposals.
- 9. Update on park surplus funds application, preparation of water, sewer, and drainage bond application no. 12, and authorize preparation of water, sewer, and drainage bond application no. 13.
- 10. West Harris County Regional Water Authority matters, including surface water delivery and construction of surface water line for water plant no. 2.
- 11. Landscape architect's report, including authorize design, approve plans and specifications, authorize advertisement for bids, review bids and award construction contracts, approve pay estimates and change orders, substantial completion, and final acceptance, for landscaping/park facilities, and, if appropriate, discuss pond 1H landscape development matters.
- 12. Report regarding development in the District.

- 13. Reports from District consultants regarding District correspondence and provision of records.
- 14. Review and revise action list.
- 15. Convene in Executive Session pursuant to Section 551.071, Texas Government Code, to conduct a private consultation with attorney to discuss pending or contemplated litigation, or a settlement offer, or to seek and receive legal advice.
