## NOTICE OF MEETING

## HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 500 (Master)

The Board of Directors of Harris County Municipal Utility District No. 500 will hold a regular Master District meeting on **Wednesday**, **December 7**, **2022**, **at 12:00 p.m.**, at <u>The Lakehouse</u>, 10000 Towne Lake Parkway, Cypress, Texas, to discuss and, if appropriate, act upon the following items:

- 1. Public comments (3-minute limit).
- 2. Approve minutes.
- 3. Contract Revenue Bonds (Water, Sewer, and Drainage Facilities), Series 2023 ("Series 2023 Bonds"), including:
  - a. review bids and award sale of the District's \$14,440,000 Contract Revenue Bonds (Water, Sewer, and Drainage Facilities), Series 2023;
  - b. adopt Resolution Authorizing the Issuance of the District's \$14,440,000 Contract Revenue Bonds (Water, Sewer, and Drainage Facilities), Series 2023;
  - c. approve Paying Agent/Registrar Agreement;
  - d. approve Official Statement;
  - e. execution of Certificate Regarding Provision of Financial Advice;
  - f. authorize the Board of Directors to sign all documents relating to the bond sale and authorize attorney and financial advisor to take all necessary action to deliver bonds to the purchaser; and

  - b. adopt Resolution(s) Expressing Intent to Reimburse.
- 6. Operation of District facilities, including:
  - a. billings, repairs, maintenance, and facility security, including telephone service options and discuss resident education plan regarding disposable wipes and rags;
  - b. update on lift station nos. 1 and 3 pump repairs;
  - c. proposal for landscaping maintenance at wastewater treatment plant site and approve related agreement, if appropriate; and
  - d. discuss preparation of five-year facility maintenance plan.
- 7. Discuss lake management and maintenance, including:
  - a. wildlife management, including report and proposals from A All Animal Control;

- b. erosion, dredging, and water quality, including report from Erosion Control Committee and update on development of lake maintenance plan; and
- c. amendments to lake rules, including request from Towne Lake Community Association and amendment to District lake rules.

    - i. design of grade separation at Union Pacific Railroad and intersection improvements at Highway 290 project and, if appropriate, approve related Task Orders;
    - ii. approve Advance Funding Agreement Amendment No. 1 and new Surface Transportation Block Grant Advance Funding Agreement with TxDOT, and adopt Resolution Approving Advance Funding Agreement;
    - iii. update on Houston-Galveston Area Council Transportation Improvement Program participation;
    - iv. Interlocal Agreements with funding partners;
    - v. project schedule; and
    - vi. updated analysis of financial impact of project.
  - b. report on stormwater facilities maintenance and repairs, and approve Submerged Storm Sewer Agreements and Maintenance Agreements;
  - c. authorize design, approve plans and specifications, authorize advertisement for bids, and review bids and award construction contracts, including for the following construction projects:
    - i. Mound Road east utility extension;
    - ii. wastewater treatment plant no. 1 expansion, Phase 4; and
    - iii. Barker Cypress left turn lane.
  - d. approve pay estimates, change orders, substantial completion, final acceptance, termination, and/or settlement agreements, including for the following construction projects:
    - i. wastewater treatment plant no. 2;
    - ii. emergency water interconnect with Harris County Municipal Utility District No. 196;
    - iii. Towne Lake Section 60 temporary access road; and
    - iv. water plant no. 1 water well no. 1 and hydropneumatic tank addition.
  - e. approve requests for capacity reservations and utility commitment letters; and

- f. discuss potential reclaimed water facilities at Horsepen Creek Wastewater Treatment Plant.
- 10. Accept or grant conveyance of deeds, utility deeds, and easements, approve consents to encroachment, rights of entry, abandonments of easements and environmental proposals.
- 11. Update on preparation of water, sewer, and drainage bond application no. 13 and preparation of road bond issue no. 5.
- 12. West Harris County Regional Water Authority matters, including surface water delivery and construction of surface water line for water plant no. 2.
- 13. Landscape architect's report, including authorize design, approve plans and specifications, authorize advertisement for bids, review bids and award construction contracts, approve pay estimates and change orders, substantial completion, and final acceptance, for landscaping/park facilities, including:
  - a. wastewater treatment plant no. 1 landscape improvements.
- 14. Report regarding development in the District.
- 15. Reports from District consultants regarding District correspondence and provision of records.
- 16. Review and revise action list.
- 17. Convene in Executive Session pursuant to Section 551.071, Texas Government Code, to conduct a private consultation with attorney to discuss pending or contemplated litigation, or a settlement offer, or to seek and receive legal advice.
