# NOTICE TO PURCHASER OF SPECIAL TAXING OR ASSESSMENT DISTRICT

The real property that you are about to purchase is located in the Harris County Municipal Utility District No. 500 (the "District") and may be subject to District taxes or assessments. The District may, subject to voter approval, impose taxes and issue bonds. The District may impose an unlimited rate of tax in payment of such bonds. The current rate of the District property tax is \$0.947 on each \$100 of assessed valuation.

The total amounts of bonds payable wholly or partly from property taxes, excluding refunding bonds that are separately approved by the voters, approved by the voters are:

\$31,250,000 for water, sewer, and drainage facilities;  
\$14,230,000 for road facilities; and  
\$20,000,000 for parks and recreational facilities.

The aggregate initial principal amounts of all such bonds issued are:

\$2,000,000 for water, sewer, and drainage facilities;  
\$0 for road facilities; and  
\$0 for parks and recreational facilities.

In addition to the above bonds, the District is obligated by a contract approved by the voters to pay its pro rata share of the debt service of contract revenue bonds to finance the regional facilities to serve the District and the three other municipal utility districts that are part of the Towne Lake regional system. An aggregate of \$1,169,810,000 in bonds have been authorized to finance these regional facilities and for the purpose of refunding such bonds.

The District is located wholly or partly in the extraterritorial jurisdiction of the City of Houston. Texas law governs the ability of a municipality to annex property in the municipality's extraterritorial jurisdiction and whether a District that is annexed by the municipality is dissolved.

The District has entered into a strategic partnership agreement with the City of Houston. This agreement may address the timeframe, process, and procedures for the municipal annexation of the area of the District located in the municipality's extraterritorial jurisdiction.

The purpose of the District is to provide water, sewer, drainage, flood control, road, parks and recreational facilities and services. The cost of District facilities is not included in the purchase price of your property.
