

## NOTICE OF MEETING

### HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 500 (Master)

The Board of Directors of Harris County Municipal Utility District No. 500 will hold a regular Master District meeting on **Tuesday, July 8, 2025, at 12:00 p.m.**, at **The Lakehouse, 10000 Towne Lake Parkway, Cypress, Texas**, to discuss and, if appropriate, act upon the following items:

1. Public comments (3-minute limit).
2. Approve minutes.
3. Series 2025A Contract Revenue Bonds (Road Facilities) matters, including:
  - a. review bids and award sale of the District's \$9,640,000 Contract Revenue Bonds (Road Facilities), Series 2025A;
  - b. adopt Resolution Authorizing the Issuance of the District's \$9,640,000 Contract Revenue Bonds (Road Facilities), Series 2025A;
  - c. approve Paying Agent/Registrar Agreement;
  - d. approve Official Statement;
  - e. execution of Certificate Regarding Provision of Financial Advice;
  - f. authorize the Board of Directors to sign all documents relating to the bond sale and authorize attorney and financial advisor to take all necessary action to deliver bonds to the purchaser;
  - g. approve payment to Attorney General relating to bond issue transcript review; and
  - h. approve developer reimbursement report and authorize disbursement of bond proceeds.
4. Approve Annual Report and authorize filing of same in accordance with the District's Continuing Disclosure of Information Agreement and as required by SEC Rule 15c2-12.
5. Annual Review of Procedures for Continuing Disclosure Compliance.
6. Renewal of District's insurance policies.
7. Financial and bookkeeping matters, including:
  - a. payment of the bills, review of investments, collection of monthly charges for operation and maintenance, and fund transfers; and
  - b. adopt Resolution(s) Expressing Intent to Reimburse.
8. Operation of District facilities, including billings, repairs, and maintenance.
9. Discuss lake management and maintenance, including:
  - a. wildlife management, including report and proposals from A All Animal Control;
  - b. erosion, dredging, and water quality, including update on development of lake maintenance plan; and

- 11. Engineering matters, including:
  - a. grade separation at Union Pacific Railroad and intersection improvements at Highway 290, including:
    - i. design of grade separation at Union Pacific Railroad and intersection improvements at Highway 290 project and, if appropriate, approve related Task Orders;
    - ii. update on Houston-Galveston Area Council Transportation Improvement Program participation;
    - iii. Interlocal Agreements with funding partners;
    - iv. project schedule; and
    - v. updated analysis of financial impact of project.
  - b. authorize design, approve plans and specifications, authorize advertisement for bids, and review bids and award construction contracts, including for the following construction projects:
    - i. wastewater treatment plant no. 1 expansion, Phase 4 and access road improvements;
    - ii. reservoir dredging project, phase one;
    - iii. lift station no. 1 rehabilitation project; and
    - iv. Asher Trailhead at Towne Lake water, sewer, drainage, paving and sidewalk improvements.
  - c. approve pay estimates, change orders, substantial completion, final acceptance, termination, and/or settlement agreements, including for the following construction projects:
    - i. wastewater treatment plant no. 1 emergency generator;
    - ii. hooded Greenhouse Road left turn lane south of Cypress North Houston; and
    - iii. lake erosion rehabilitation project.
  - d. update on water plant and lift station coating inspections;
  - e. discuss options for water reuse, including report from reuse committee; and
  - f. approve requests for capacity reservations and utility commitment letters.
- 12. Accept or grant conveyance of deeds, utility deeds, and easements, approve consents to encroachment, rights of entry, abandonments of easements, and environmental proposals.
- 13. Update on preparation of park bond application no. 2.
- 14. West Harris County Regional Water Authority matters.
